First Time Home Buyer Benefits

Financial incentives for first-time buyers can include tax benefits, subsidies, and favourable loan terms.

B.C. First-Time Home Buyers' Program

To qualify for the maximum exemption of \$8,000, your home must be worth no more than \$835,000. In practice, that means you'll pay no land transfer tax on a home valued up to \$500,000. Homes worth between \$500,000 and \$835,000 will have \$8,000 knocked off the bill, but you'll end up paying some tax. Partial exemption available up to \$860,000.

B.C. Home Owner Grant

To receive the full grant, your home's assessed value can't exceed \$2,125,000. If your home is worth more than the threshold amount, your grant will be reduced by \$5 for each \$1,000 over the threshold. Homes valued above \$2,264,000 (or \$2,304,000 in a rural, northern area) are ineligible for grants.

Newly Built Homes Exemption

This exemption may reduce or erase the property transfer tax you pay when purchasing a new construction home worth up to \$1.1 million that sit on no more than 1.24 acres of land.

FIRST HOME SAVINGS ACCOUNT

You can contribute up to \$8,000 per year to an FHSA, up to a maximum of \$40,000. The contributions, which are tax-deductible, can be used to purchase investment products — stocks, bonds, GICs — that might increase your savings more rapidly. The earnings these investments generate are tax-free.

HOME BUYERS' PLAN

The Home Buyers' Plan allows you to take up to \$60,000 out of an eligible registered retirement savings plan, or RRSP, to put toward the down payment of your primary residence. Any funds you take out of your RRSP are tax-free, but you must repay them within 15 years.

PRE-APPROVAL



Getting a Pre-Approval

Estimate of borrowing capacity for a home purchase before finding a property.

- Speak with a lender (bank, credit union, etc.).
- Address any credit issues.
- Receive a Pre-Approval that lasts 90-120 days.

Closing on Your New Home

Complete the closing process on your new home with your legal professional.

- Review closing statements.
- Sign closing documents.
- Register title and get relevant title insurance.



Taxes and Other Fees

Additional Costs To Consider

PROPERTY TRANSFER TAX (PTT)

- 1% on the first \$200,000
- 2% on the portion greater than \$200,000 to \$2,000,000
- 3% on the portion greater than \$2,000,000
- Additional 2% on residential property over \$3,000,000

Qualifying first-time home buyers may be exempt from paying the PTT if the purchase price of their home is priced up to \$500,000. There is a partial exemption for homes priced between \$500,000 and \$525,000. Above \$525,000 there is no rebate.

Qualifying buyers of newly constructed homes may be exempt if the purchase price of their home is priced up to \$750,000. There is a partial exemption for homes priced between \$750,000 and \$800,000. Above \$800,000 there is no rebate.

LAWYER OR NOTARY & FILING FEES

Buyers are required to hire a Lawyer or Notary Public to draft closing documents which ensures the title of the home is properly and successfully transferred. Fees usually vary from \$900 to \$2,000 plus GST and PST.

TITLE INSURANCE

On the completion date, your Lawyer/Notary will offer title Insurance that can range between \$225-\$350 depending on the property type.

GST

The statement applies to the purchase price of a newly constructed home or one that has never been occupied. When buying a new home, the Goods and Services Tax (GST) amounts to 5% of the purchase price. However, buyers may qualify for rebates or partial rebates if the purchase price of the new home based on the price. Additionally, buyers are responsible for paying the GST on fees associated with services rendered by appraisers, home inspectors, lawyers, Notary Publics, and REALTORS®.

HOME INSPECTION

A home inspection is a report on the condition of the home and includes structural and moisture problems, as well as electrical, plumbing, roofing and insulation. Fees can vary from typically \$400 - \$900 plus GST depending on the size of the home and the complexity of the inspection. Some inspectors also charge an additional fee for an older home or a home with a secondary suite, a crawlspace, or a laneway home

Taxes and Other Fees

Additional Costs To Consider

HOME APPRAISAL FEES (IF APPLICABLE)

Financial institutions require an appraisal of a property before the mortgage is finalized in order to ensure the collateral protects them adequately. This fee can be in a range between \$300 to \$500 depending on the appraiser chosen by the bank.

MORTGAGE INSURANCE

The federal government requires high ratio mortgages with less than 20% down payment to be insured against default. To get mortgage loan insurance, you'll need a minimum down payment. The amount depends on the home's purchase price:

- If the home costs \$500,000 or less, you'll need a minimum down payment of 5%.
- If the home costs more than \$500,000, you'll need a minimum of 5% down on the first \$500,000 and 10% on the remainder.
- If the home costs \$1,000,000 or more, mortgage loan insurance is not available, and you will need at least a 20% down payment.

HOME BUYERS PLAN (HBP) FROM YOUR RRSP

Canadians could withdraw as much as \$60,000 from their RRSP, up from the previous limit of \$35,000. Couples purchasing a home together would be able to withdraw up to \$120,000 from their RRSPs to purchase a new home.

STRATA FEES

Generally applies to condos, townhomes and attached housing. Strata fees are typically used to cover shared expenses and maintenance costs for common areas and amenities, such as elevators, parking lots, lobbies, gyms, and swimming pools.

PRORATED ADJUSTED TAXES & UTILITIES

Determined by the timing of sale

- E.g. December 23rd completion, total taxes for the year \$1,500.

FIRST-TIME HOME BUYERS' TAX CREDIT

HOME OWNER GRANT (BC)

Under the B.C. Home Owner Grant, a home owner may be eligible to reduce the amount of annual property taxes they pay on their principal residence.
